CHAPTER 4

CONCLUSION

This chapter will discuss the conclusion of the analysis. Based on the previous analysis, the researcher found that Mitch had some kinds of artfulness, such as intelligence, skillful, critical and not easily deceived, crafty, persuasive, and curious. By these characters that include in his artfulness, he could achieve some achievements.

As an intelligent person, Mitch always quickly understands the situation. His personal competence made him easily understand and control the emotions so that emotions don't control him. Moreover, by his social competence, he could manage his relationship with others, including their emotions. His personal intelligence has been able to help him achieve several achievements such as being one of the top five students at Harvard Law School, hired by small tax firm in Memphis, Bendini Lambert & Locke with considerable salary, and completing the work in the target set by the firm.
