CHAPTER IV

CONCLUSION AND SUGGESTION

I. CONCLUSION

After analyzing the novel and the movie, the researcher concludes that a text may influence other text. It can be seen from story line of the movie adapting the story of novel that there are some parts that are added, subtracted, even in the modification and it certainly raises differences.

Reflecting to the data analysis, the conclusion is firstly Holly's effort in the novel is seen in several aspects, among others is working aspect, with looking a new job, which initially she worked as a secretary in the bureau of law and now she work in advertising company. The second aspect is socializing, she also wants to socialize with her family, her friends, and the environment after 2 weeks do not get out from her house. Holly began to dare to visit to salon, café, pub and Lanzarotte to meet and go on vacation with her friends. The third aspect is having a new love, after Holly left Gerry, she feel comfort with other men, that is Daniel, but Holly do not want to give her love for Gerry, because Holly still loving Gerry

Secondly, the description of Holly's effort different in the movie is if seen from the working aspect, the director change a storyline from novel, that is by replacing the initial Holly's work is as secretary converted into an apartment's seller, and her new job which was originally to be a seller of advertising, it became a shoes entrepreneur. The other Holly's effort in the movie is partying and go to the park, in the novel the author never seen that Holly entertaining herself with goes to partying and go to the park. This

shows that the director changed the storyline. The last is having holiday, here the director still raises Holly's holiday with her friends as shown in the novel, but the director changed the holiday's purpose that is in Ireland not to Lanzarotte. In the end, the movie's director still take some original story from the novel but there is a modified.

Thirdly, the reasons why the differences happen is different background of the author, the novel written by Cecelia Ahern, whereas the movie written by Richard LaGravenesseit is become one of the causes of the differences that occur in both works, because the author of the novel did not become the author of the movie. The other reason is because of different setting, Cecelia Ahern from Ireland, whereas Richard LaGravenesse from New York, the difference in their place of residence can affect the setting in a story they have made. The last reason is because of different characterization. Irish people has a characteristic of it is own, that is hospitality, friendly, love to talk. Whereas Richard is American people has a characteristics that is arrogant, individualism, ignorant and workaholic. The character of each country they also eventually affect the figures of the story they were making.

II. SUGGESTION

Based on the conclusion above, there are some suggestions given by the researcher to the other researchers in order to do a better research in the future.

1. There are some Holly's effort in the novel and the movie PS. I Love You and there are some reasons of differences between novel and movie that have not been explained in this thesis yet. Thus, the readers can establish a new analysis that has not been found.

2. If the readers want to analyze further about Holly's effort using intertextuality theory, the researcher suggests the readers to find any texts—novels, short stories, or poems. The analyses must understand both the theory and the text.

The writer hopes this thesis can give a contribution to the English major students who want to analyze about the same topic.
