## **CHAPTER 1**

## INTRODUCTION

#### **1.1 Background of the Study**

Literature is as the expression of beautiful thoughts, feeling, and human experience in beautiful language. Literature is an art activity that related to imaginative or creative writing. Every person has imaginative thought in their minds. They think about something unreal or even real things in this world. Moreover, they can share their imaginative thinking by expressing into a form of inspiration. It can give the depth inspiration about what that we have known in this world (Borges 18). The one of the famous novels is *A Farewell to Arms* (1929). It was written by Ernest Hemingway. *A Farewell to Arms* is an inspiration from a real story by Ernest Hemingway (Mammadov3). *A Farewell to Arms* takes place during World War I when the Italian Army was fighting against Austrian troops. In 1914-1918 when First World Warhappenedthe new literature produced by second generation women's peace historians. It called post feminism era that witnessed the flowering of an international women's peace movement that linked pacifist ideals to a larger world movement for women and human right (Judith 4).

A Farewell to Armstells about the vague reality of war, the relationship between love and pain and the struggle of some characters for their life. This case of this story is when Catherine Barkley meets Lieutenant Frederic Henry. Catherine Barkley is a nurse in hospital located in Milan and Lieutenant Henry is a young American ambulance driver in Italian army (Hemingway 5).

Catherine Barkley has fiancé before, but her fiancé died. So, she is moved to a hospital located in Milan. Then, she meets Lieutenant Frederic Henry. Thus, she begins to face her real life after the death of her fiancé (6). She tries to open her heart for another man, and he is Lieutenant Frederic Henry. She falls in love with Lieutenant Frederic Henry (9). Therefore, she begins her daily life just with Lieutenant Frederic Henry (32). In their relationship, Catherine pledges to be faithful to Henry. She always shows happy face and always smiles to Henry and she does not like if their relation will be compared with others. In the middle of their journey, Catherine gets pregnant for about three months. In fact, they have not married yet (40). The other hand, Lieutenant Frederic Henry also goes for world war. Then, Catherine faces her heavy life just alone. She undergoes her daily routine without any changes with always wait Henry. She works like usual in hospital (42).

Someday, Henry comes and they become one in a life. They live together without clear status. They live like other couple; they walk and eat together every day. She always calls Henry with "darling" and smile in every moment (77). Furthermore, in the end of this story, Catherine has a serious problem with her pregnancy, but Catherine always says that she is fine to Henry. In a serious situation of her pregnancy, she does not forget to remind Henry to eat (90). The doctor tells Henry that the best solution would be a Caesarean operation. The baby boy is born and Catherine asks about their son. When Henry goes out for dinner and he returns, the nurse tells that Catherine is hemorrhaging. It is serious situation and she finally dies after bearing the baby (95).

Actually, not all human being can face their life patiently and strongly. There are some ways to make them in order to be strong and peaceful. Catherine faces the hard life without a husband and unmarried status. Her struggle is as nurse in hospital to fulfill her necessity without asking to Henry, Therefore, she dies because of sanguinary after delivering her baby.From this case, it represents woman action in literature; it is about the version of feminist and focuses on Catherine Barkley.

For better result to understanding the literary work massage, it needs to make analysis and research of the literary works. To do that, the researcher needs a tool to get better research. It talks about feminism; feminism is a theory that explains about women movement to refuse inequality in political, social, and economictomen (Ratna184). So, to conduct the research and make the research stronger, the researcher usesRadical Feminism and to know more about the characterization of Catherine Barkley, the researcher usesPsychoanalysis theory by Sigmund Freud as supporting theory.

For more specific, the researcher uses Radical feminism also to explain that a woman is not just sex class, Radical feminism analyses the relationship between social inequality and sexual difference; the domination of women by men is seen to provide the foundation of social inequality, and the sexual oppression of women is seen to underlie the economic, cultural and social subordination of women (153).Then, Psychoanalysis is a theory about personality structure of human personality; there are three kinds that grow chronologically: Id, ego and Superego (Sigmund Freud in Corey 14).
