# **CHAPTER I**

# **INTRODUCTION**

### 1.1 Background of the Study

Language is one of the tools of communication. In social life, people always communicate each other by using language. There is a system to build human communication by using language. According to Holmes (1992:2) people use language to ask for and give information. It means their specific purpose is to give and receive information from other. It is impossible for people to communicate without language.

They have different ways in influencing people's lives such as in behavior, attitude, or even in the way of using language in community of society they live in with by different of conditions: different occasion, different discussion, different relationship between the speaker and hearer.It is depend on the context itself. This research is related with sociolinguistics. According to Holmes (1992:2) "Sociolinguistics is concerned with the relationship between language and the context in which it is use". It means that people as members of a society must manage and maintain a good social relationship with others. When they get interaction with society, they are supposed to reconcile the language as well. Therefore, interaction is possible to take place in a society interaction. In this case, it may be brought by different style of the language. Thus, it will also describe the different occasion, discussion and relationship between the speaker and hearer.

As one type of language variety is style which refers to the choice of certain linguistic forms that have the same meaning. It has an important role in communication. In this case, a speaker uses different styles in order to do not bother the situation of speaking and not to offend the hearer. Language style refers to convey the same information using different expression. It is related to different variations of language used in different situations and needs. The participant has to apply the right style depends on the situation and condition Trudgill (1974:103).Related to the explanation above, David (1980:337) says, style refers to the relationship among the participant in a language activity especially the level of formality they adopt. It means the style of person indicates the characteristic when he gets speech activities with others and each person will get differences of style. In reality each kinds of style are used for different occasion and purpose.

Trudgill (1974: 124) says that individual style is unique combination of language units, expressive means and stylistic devices peculiar to a given writer which makes that writer's works or even utterances easily recognizable. It means that every human being has their own style in using language. The style can show the writer or the speaker personality, identity and also their characteristics. The language style expresses people's feelings through their language use, both orally and written form. To know how the writers or speakers use their language style in conveying their thinking to the people is very interesting. In speaking, the speaker delivers his or her message in order to be heard and known what he or she wants directly.

Movie is a term that encompasses individual motion pictures, the field of movie as an art form and the motion picture industry. Movie is produced by recording images from the world with cameras or by creating images using animation technique or special effects Sulis (2008:3).Further, movies are cultural artifacts created by specific cultures. 1. Style
