## **CHAPTER V**

## **CONCLUSION AND SUGGESTION**

## **5.1 Conclusion**

The writer used Testimony in Dian Sidoarjo as the object of this study because the utterances in this testimony used beautiful words. Likes choice of words which seduce, although disobey Cooperative Principle. Sometimes the utterance is excessive and each of sentences did not relate so, the words in testimony can be close to flouting maxims. Based on the findings above, the writer concluded this study based on the formulated research problems. First, testimony in Dian Sidoarjo flouted all the maxims; flouting maxim of quality, flouting maxim of quantity, flouting maxim of manner and flouting maxim of relation. There were 30 utterances containing flouting maxims, which maxim of quantity took the dominance as shown in 14 utterances, whille there are 7 utterances flouting maxim of quality, 3 utterances flouting maxim of manner and 6 utterances flouting maxim of relation. Mostly, the utterances are produced by Dian.

Second, the way of maxims were flouted testimony in Dian Sidoarjo has been classified in the findings. It has been showed if there were two ways of flouting maxim of quantity they were less informatioan in 4 utterances and much information in 10 utterances. Then, the way flouting maxim of quality was done by said in lack adequate evidence and said as true in 7 utterances. While, the way flouting maxim of manner was done by said unclear, ambiguity and difficult to understand the reader, it has showed 3 utterances. The last, there were two ways of flouting maxim of relation, it was produced by change the topic conversation and gave unnecessary

Third, there were some reasons of testimony in Dian Sidoarjo flouted maxims; to help the customer understand more about the products, to convey the feeling, to make sure the reader about the product, to make the customer curious with the product and to promote the product.

The writer also put some verses and hadits to be additional information in flouting maxim of quality. The writer provides it, in order to know the prohibition of said untrue according to Islamic law. The writer expected to the reader can take the wisdom from those additional information. So that, the speaker are expected to avoid flouting maxim of quality. The writer has not found another invention which can be related with another flouting maxims. Thereby, the further researchers hoped to add some information which related another maxims in order to help the speaker avoid flouting maxims in every conversation.

## 5.2 Suggestion

The writer expects the reader and the next researchers can understand more about Cooperative principle by Grice theory. It means that the writer wanted to the reader can understand how to interact with one another in the right way and how to make the conversation to be successful. This study also hopes to the reader and the further researchers to do research about Cooperative Principle in the new object, which has not been investigated by the previous researchers.

The study about flouting maxim of conversation will remain as interesting discussion because some of speaker do not know how people normally behave in conversation. So that, Grice's maxim becomes recommended for the next researchers to relate the study with those case. The writer also suggests to relate the study with some previous researchers that have similar area to compare the different topic, although the focus of the study is different.
