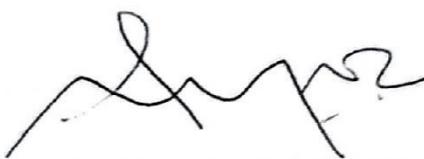

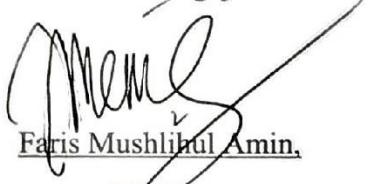

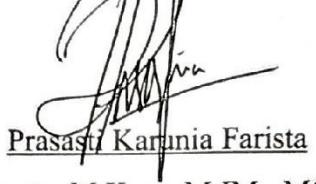

ABSTRAK

Gangguan dalam sebuah rantai pasokan, hal ini muncul sebelum adanya istilah manajemen rantai pasokan, banyaknya gangguan mulai dari gangguan rantai pasokan karena perubahan ekosistem, transformasi model bisnis, serangan siber, hingga Covid-19 yang menyebabkan tidak stabilnya sebuah rantai pasokan yang ada. Di samping itu, situasi dalam penelitian sebelumnya dibandingkan dengan situasi saat ini juga mengalami perbedaan karena dampak pandemi Covid-19. Dengan mempertimbangkan kendala tersebut, penelitian ini bertujuan untuk menyelidiki publikasi terbaru yang menerapkan manajemen risiko rantai pasokan sebagai komponen kunci dari manajemen rantai pasokan, mengelola dan memprediksi risiko gangguan yang mengarah pada *sustainability* rantai pasokan. Tugas akhir ini dilakukan dengan metode kuantitatif yang didasarkan pada pencarian secara sistematis dan analisis jaringan bibliometrik. *Systematic review* mencakup teknik kuantitatif (meta-analisis) dan teknik kualitatif (meta-sintetis). Diharapkan dalam penelitian ini memberikan kontribusi penting bagi literatur dalam menerapkan *supply chain risk management* sebagai komponen kunci dari *supply chain management*, dalam mengelola dan memprediksi risiko gangguan yang mengarah pada *susainability* rantai pasokan. Meningkatkan kesadaran tentang pentingnya manajemen risiko dan keberlanjutan dalam rantai pasokan dikalangan pemangku kepentingan bisnis maupun organisasi, serta memberikan panduan praktis bagi organisasi yang ingin meningkatkan manajemen risiko rantai pasokan mereka, terutama dalam menghadapi risiko gangguan yang bermacam-macam. Studi ini pertama kali menggunakan metode SLNA dengan tool Orange

Data Mining dalam praktik menganalisis bibliometrik untuk topik manajemen risiko rantai pasokan.

Disruptions in a supply chain, this appeared before the term supply chain management, many disruptions ranging from supply chain disruptions due to ecosystem changes, business model transformation, cyber attacks, to covid-19 which caused the instability of an existing supply chain. In addition, the situation in previous studies with the present is also different because of the post-Covid-19 pandemic. Departing from these limitations, this study aims to investigate recent publications that apply supply chain risk management as a key component of supply chain management, managing and predicting the risk of disruptions that lead to supply chain sustainability. This final project was conducted using quantitative methods based on systematic search and bibliometric network analysis. Systematic review includes quantitative techniques (meta-analysis) and qualitative techniques (meta-synthesis). It is expected that this study provides an important contribution to the literature in applying supply chain risk management as a key component of supply chain management, in managing and predicting the risk of disruptions that lead to supply chain sustainability. Raising awareness about the importance of risk management and sustainability in supply chains among business and organizational stakeholders, as well as providing practical guidance for organizations looking to improve their supply chain risk management, especially in the face of varying disruption risks. This study is the first to use the SLNA method with the Orange Data Mining tool in the practice of analyzing bibliometrics for the topic of supply chain risk management.

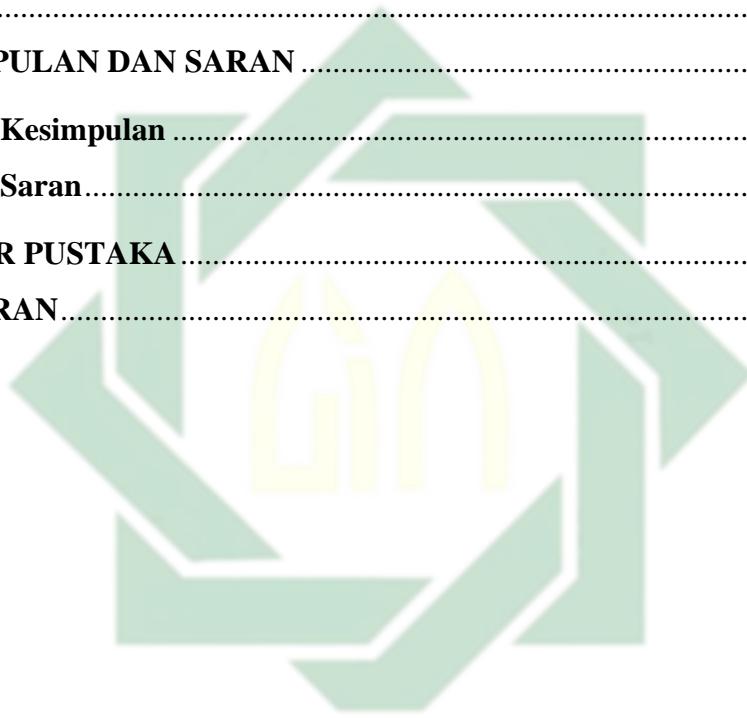

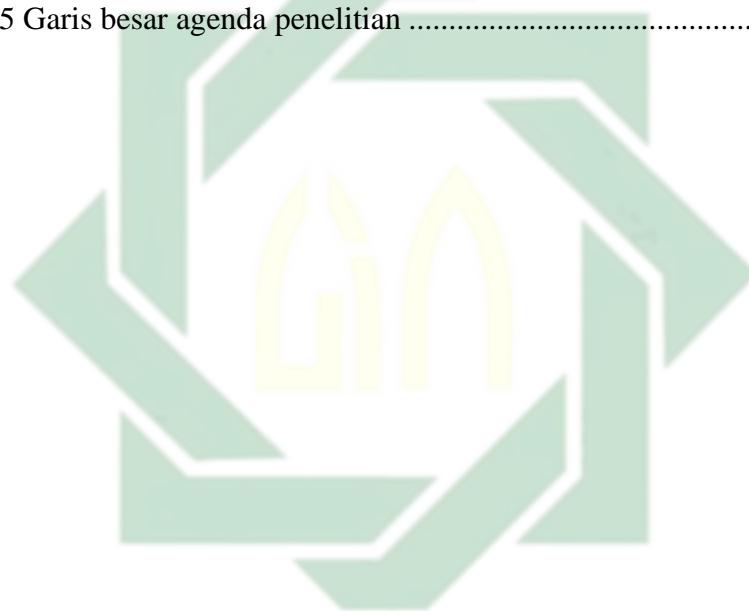
