ABSTRACT

This study aimed to examine the presence of flouting maxims in the humorous dialogue used in the movie *A Man Called Otto*. The movie told the story of grief, love, and the strength of the characters to heal their wounded hearts, which was conveyed through a combination of moving moments and humor, thus involving the flouting maxims to create a humorous effect. Therefore, in this study, the author addressed the formulation of the problems, namely (1) What are the maxims flouted by the characters to create humor in *A Man Called Otto* movie? (2) What are the styles of humor created by flouting maxims in *A Man Called Otto* movie?

This research used a qualitative approach to provide a thorough understanding of the subjective aspects of the phenomenon under study. The descriptive qualitative approach in textual analysis examined the main character's conversation in the movie script. The data were obtained by watching the movie and reading the transcript in *A Man Called Otto*, and then the data were collected by transcribing the dialogue from the movie. The transcription results were then analyzed to identify the types of flouting maxims using the appropriate codes in the text. The analysis continued by identifying the various styles of humor used by the characters in the movie.

The results of this study showed that all flouting maxims (flouting maxim of quantity, flouting maxim of quality, flouting maxim of relevance, flouting maxim of manner) and all humor styles (affiliative humor, self-enhancing humor, aggressive humor, self-defeating humor) occurred in this movie. In the relationship between the flouting maxim and humor style, the author found that among all the flouting maxims, Otto's character tended to use the flouting maxim of manner and self-defeating humor. This was to create a comedic effect, deepen the characterization, and develop the narrative. The flouting maxim of manner created confusing and humorous situations. At the same time, self-deprecating humor helped reveal Otto's emotional side and vulnerability, making him a complex and recognizable character to the audience.

ABSTRAK

Penelitian ini bertujuan untuk meneliti adanya pelanggaran maksim dalam dialog humor yang digunakan dalam film *A Man Called Otto*. Film ini menceritakan tentang kesedihan, cinta, dan kekuatan para karakter untuk menyembuhkan hati yang terluka, yang disampaikan melalui campuran momen yang mengharukan dan humoris, sehingga melibatkan pelanggaran maksim untuk menciptakan efek humor. Dalam studi ini penulis akan menjawab rumusan masalah dalam penelitian ini yaitu (1) Apa saja maksim yang dilanggar oleh para tokoh untuk menciptakan humor dalam film *A Man Called Otto*? (2) Apa saja gaya humor yang tercipta dari pelanggaran maksim dalam film *A Man Called Otto*?

Penelitian ini menggunakan pendekatan kualitatif untuk memberikan pemahaman yang menyeluruh dan mendalam tentang aspek-aspek subjektif dari fenomena yang sedang diteliti. Pendekatan deskriptif kualitatif dalam analisis teksual digunakan untuk mengkaji percakapan karakter utama dalam naskah film. Data diperoleh dengan menonton film dan membaca transkrip film *A Man Called Otto*, selanjutnya data dikumpulkan dengan cara mentranskripsi dialog dari film tersebut. Transkripsi tersebut kemudian dianalisis untuk mengidentifikasi jenis pelanggaran maksim menggunakan kode-kode yang sesuai dalam teks. Analisis dilanjutkan dengan mengidentifikasi berbagai gaya humor yang digunakan oleh karakter dalam film.

Hasil studi menunjukkan bahwa terjadi keempat pelanggaran maksim yang terpenuhi yaitu (pelanggaran maksim kuantias, pelanggaran maksim kualitas, pelanggaran maksim relevansi, dan pelanggaran maksim cara) dan hasil menunjukkan keempat gaya humor yang terpenuhi yaitu (humor afiliatif, humor yang meningkatkan diri, humor agresif, dan humor yang mengalahkan diri sendiri) telah diaplikasikan dalam film ini. Dalam hubungan pelanggaran maksim dan gaya humor, penulis menemukan bahwa dari keseluruhan pelanggaran maksim yang ada, tokoh Otto cenderung untuk menggunakan pelanggaran maksim cara dan humor mengalahkan diri sendiri. Dia bukan hanya menciptakan efek komedi, tetapi juga untuk mendalami karakterisasi dan mengembangkan narasi. Pelanggaran maksim cara menciptakan situasi yang membingungkan dan lucu, sementara self-defeating humor membantu mengungkap sisi emosional dan kerentanan Otto, menjadikannya karakter yang kompleks dan dapat dikenali oleh penonton.


