



ABSTRACT

Islam as one of the last divine religions comes as falsifies of the previous religions. Islam which was brought by Muhammad SAW who were mandated by God the Almighty as the last prophet and messenger to earthed Quran which became the words of Allah. Islam as a religion has a holy book, the Quran; it contains values that must be met by every adherent of Islam. Inside were the laws of God that must be obeyed by humans as God's creatures. As Muslims' holy book of course the content grip of Quran must be understood correctly. In the course of Islam should also by studying the prophetic hadith as *bayan lil Quran* that comes from God to Muhammad. The position of *hadith* as *bayan lil qur'an* still need to be researched a lot to ensure that *hadith* is relevant for explaining Quran contents. *Hadith* is a source of Islamic teachings and law after the Quran very different to the structure of which is the revelation of the holy Quran. In the history, *hadith* was performed by a decline in transmitting a friend who is played by the prophet, the prophet himself with the editor of the decline of a revelation. Proficiency level in these things is different from the holy Quran as *Kalamullah*, which was inspired by deriving in accordance with the editor when the revelation was revealed to the Prophet.
