ABSTRACT

This research focuses on analyzing the types of illocutionary acts in the utterances of the main character, Queen Elizabeth II, in the first episode of *The Crown* season 1. This research involves Searle's theory, classifying illocutionary acts into five parts: representative, directive, commissive, expressive, and declarative. Therefore, this study has two problems: (1) What are the types of illocutionary acts used by the main character in *The Crown* season 1 series? (2) Which types of illocutionary acts are most often used by the main character in *The Crown* season 1 series?

This research used a descriptive qualitative method. This study took data from utterances of the main character, Queen Elizabeth II in the first episode of *The Crown* season 1 series. The researcher used several steps in collecting data, including watching the series, downloading transcripts, matched the transcripts so that no utterances from the main character were missed. Then, the researcher identified data by highlighting Queen Elizabeth II's utterances, which are included in the types of illocutionary acts. In addition, this study applied appropriate coding to help the researcher identify and classify the types of illocutionary acts based on their types. Furthermore, the analysis continued by describing the data based on the theory.

The results obtained are 25 data classified into five types of illocutionary acts. Among them are 9 representative data with a percentage of occurrence of 36%, 5 directive data with a percentage of occurrence of 20%, 7 expressive data with a percentage of occurrence of 28%, 2 commissive data with a percentage of occurrence of 8%, and 2 declaration data with a percentage of occurrence of 8%. So it can be seen that the type of speech act most often used is representative with a percentage of occurrence of 36% of 100% complete data. These data show that Queen Elizabeth II is a realistic, honest, humble figure, and has a commitment to duties and responsibilities.

ABSTRAK

Penelitian ini berfokus pada analisis jenis-jenis tindak ilokusi dalam ujaran karakter utama, Ratu Elizabeth II, dalam episode pertama awal serial *The Crown* musim 1. Penelitian ini menggunakan teori Searle yang mengklasifikasikan tindak ilokusi menjadi lima bagian, di antaranya representatif, direktif, komisif, ekspresif, dan deklarasi. Oleh karena itu, penelitian ini memiliki dua masalah: (1) Apa saja jenis-jenis tindak ilokusi yang digunakan oleh karakter utama dalam serial *The Crown* musim 1? (2) Jenis tindak ilokusi apa yang paling sering digunakan oleh karakter utama dalam serial *The Crown* musim 1?

Penelitian ini menggunakan metode kualitatif deskriptif. Penelitian ini mengambil data berupa ujaran dari karakter utama, Queen Elizabeth II dalam episode pertama serial *The Crown* musim 1. Peneliti menggunakan beberapa langkah dalam mengumpulkan data, antara lain menonton serial, mengunduh transkrip, mencocokkan transkrip agar tidak ada ujaran dari karakter utama yang terlewatkan. Kemudian, peneliti mengidentifikasi data dengan menyoroti ujaran-ujaran Ratu Elizabeth II yang termasuk ke dalam jenis-jenis tindak ilokusi. Selain itu, penelitian ini menerapkan pengkodean yang tepat untuk membantu peneliti mengidentifikasi dan mengklasifikasikan jenis-jenis tindak ilokusi berdasarkan jenis-jenisnya. Selanjutnya, analisis dilanjutkan dengan mendeskripsikan data berdasarkan teori.

Hasil yang diperoleh adalah 25 data yang diklasifikasikan ke dalam lima jenis tindak ilokusi. Di antaranya merupakan 9 data representatif dengan persentase kemunculan 36%, 5 data direktif dengan persentase kemunculan 20%, 7 data ekspresif dengan persentase kemunculan 28%, 2 data komisif dengan persentase kemunculan 8%, dan 2 data deklarasi dengan persentase kemunculan 8%. Sehingga dapat diketahui bahwa jenis tindak tutur yang paling sering digunakan adalah representatif dengan persentase kemunculan 36% dari 100% data lengkap. Data ini menunjukkan bahwa Ratu Elizabeth II merupakan sosok yang realistik, jujur, rendah hati, dan memiliki komitmen terhadap tugas dan tanggung jawab.




