



ABSTRACT

The study aims to analyze the use of types of signs in the movie The Flu. The researcher analyzed the environment in which the virus exposed the residents of Bundang city. The researcher uses Pierce's point of view to investigate the object. Two problems to be solved in this research, namely (1) what are the signs of the Bundang city environment when exposed to the virus in the movie The Flu and the hidden meaning of the signs from Pirce's perspective and (2) what are the signs of Mi-reu's condition when exposed to the virus in the movie The Flu and the hidden meaning of the signs from Pierce's perspective.

This study uses a descriptive qualitative approach. It relates to using clear and systematic descriptions of the movie under study. A descriptive study is applied in this research to collect scene parts and explain the meaning of icons, symbols, and indexes of the movie The Flu. The film features a variety of signs, including icons represented by objects, realistic artwork, artifacts, and lighting. Symbols can be found in alphabets, gestures, facial expressions, and written materials. Indexes can be identified through the situations and narratives depicted in each scene. This research uses several analytical procedures, from data collection to selecting, filtering, and labeling signs such as icons, symbols, and indices. The data source comes from the movie The Flu, which the researcher viewed from the Netflix app. Screenshots of movie sequences relating to signs have been used to create the data

This research reveals that many signs can be found in The Flu movie, the sign contain icons, symbols, and indexes. The results of this study show that the movie as a whole contains 68 signs. There are 37 signs (10 icons, 15 symbols, and 12 indexes) regarding the environmental condition of the city of Bundang when exposed to the H5N1 virus and 31 signs (12 icons, 12 symbols, and seven indexes) of Mi-reu's condition when exposed to the virus in the movie The Flu. The movie highlights the condition of the environment and individuals before and after the spread of the H5N1 virus in Bundang.

Penelitian ini bertujuan untuk menganalisis penggunaan jenis-jenis tanda dalam film The Flu. peneliti menganalisis lingkungan di mana virus tersebut memapar penduduk Kota Bundang. Peneliti menggunakan sudut pandang Pierce untuk menyelidiki objek tersebut. Ada dua masalah yang akan dipecahkan dalam penelitian ini, yaitu (1) apa saja tanda-tanda lingkungan kota Bundang ketika terpapar virus dalam film The Flu dan makna tersembunyi dari tanda-tanda tersebut dari sudut pandang Pierce dan (2) Apa saja tanda-tanda kondisi Mi-reu ketika terpapar virus dalam film The Flu dan makna tersembunyi dari tanda-tanda tersebut dari sudut pandang Pierce.

Penelitian ini menggunakan pendekatan kualitatif deskriptif. Hal ini berkaitan dengan penggunaan deskripsi yang jelas dan sistematis dari film yang diteliti. Studi deskriptif digunakan dalam penelitian ini untuk mengumpulkan bagian-bagian adegan dan menjelaskan makna ikon, simbol, dan indeks dari film The Flu. Film ini menampilkan berbagai tanda, termasuk ikon yang diwakili oleh objek, karya seni realistik, artefak, dan pencahayaan. Simbol dapat ditemukan dalam huruf, gerak tubuh, ekspresi wajah, dan materi tertulis. Indeks dapat diidentifikasi melalui situasi dan narasi yang digambarkan dalam setiap adegan. Penelitian ini melalui beberapa prosedur analisis, mulai dari proses pengumpulan data hingga pemilihan, penyaringan, dan pelabelan tanda-tanda seperti ikon, simbol, dan indeks. Sumber data berasal dari film The Flu, yang dilihat peneliti dari aplikasi Netflix. Tangkapan layar dari urutan film yang berkaitan dengan tanda-tanda telah digunakan untuk membuat data.


Penelitian ini mengungkapkan analisis kontekstual yang digunakan sebagai sumber data untuk film tersebut. Hasil dari penelitian ini menunjukkan bahwa film tersebut secara keseluruhan mengandung 68 tanda semiotik. Terdapat 37 tanda semiosis (10 ikon, 15 simbol, dan 12 indeks) mengenai kondisi lingkungan kota Bundang ketika terpapar virus H5N1 dan 31 tanda semiosis (12 ikon, 12 simbol, dan tujuh indeks) mengenai kondisi Mi-reu ketika terpapar virus dalam film The Flu. Film ini menyoroti kondisi lingkungan dan individu sebelum dan sesudah penyebaran virus H5N1 di Bundang.
