



## ABSTRAK

Perdebatan mengenai hadis tentang usia pernikahan ‘Aisyah telah menjadi sumber kritik terhadap kehidupan Nabi Muhammad Saw., khususnya karena pernikahan tersebut kerap dipandang sebagai praktik pernikahan dini yang dianggap tidak etis. Kritik ini mendorong sejumlah akademisi untuk meninjau ulang keabsahan matan hadis, tanpa menyadari bahwa penilaian mereka sering kali berakar pada nilai-nilai modernitas. Penelitian ini berangkat dari persoalan tersebut dengan merumuskan tiga pertanyaan utama: (1) Bagaimana hadis tentang usia pernikahan ‘Aisyah dipahami dalam konteks pernikahan dini? (2) Bagaimana nilai-nilai modernitas melatarbelakangi kritik terhadap matan hadis tersebut? dan (3) Bagaimana dekolonisasi kritik matan dalam pemikiran Jonathan Brown dapat diterapkan untuk menganalisis hadis tersebut?

Untuk menjawab ketiga rumusan masalah tersebut, penelitian ini menggunakan metode *Critical Discourse Analysis* (CDA) yang dikembangkan oleh Michel Foucault dan Norman Fairclough. Pendekatan ini digunakan untuk menganalisis konstruksi bahasa dan wacana dalam karya-karya Jonathan Brown serta dalam perdebatan akademik terkait hadis usia pernikahan ‘Aisyah. Proses analisis dilakukan dalam tiga tahap utama, yaitu: deskripsi, interpretasi, dan eksplanasi. Pendekatan ini dipilih karena mampu mengungkap dimensi kekuasaan dan dominasi wacana modern dalam tafsir keagamaan.

Hasil penelitian ini menunjukkan bahwa pemahaman terhadap hadis usia pernikahan ‘Aisyah terbagi dalam tiga kecenderungan: tradisionalis, modernis, dan kontekstualis, dengan kelompok kontekstualis berupaya mengembalikan makna hadis pada konteks historisnya. Kritik terhadap hadis ini banyak dipengaruhi oleh nilai-nilai modernitas, yang sering kali menghasilkan penilaian negatif. Sebagai alternatif, pendekatan ‘dekolonisasi kritik matan’ yang dirumuskan dari pemikiran Jonathan Brown menawarkan kerangka untuk membebaskan interpretasi hadis dari hegemoni modernitas, dengan menekankan pentingnya konteks historis dan warisan intelektual Islam. Oleh karena itu, pendekatan ini perlu dikembangkan lebih lanjut dalam studi-studi hadis kontemporer untuk menghadirkan pembacaan yang lebih adil dan kontekstual serta terbebas dari hegemoni modernitas atau kolonialisme intelektual.

## ABSTRACT

Ananda Prayogi, NIM. 02040623005, Decolonizing *Matn* Criticism (A Study of Jonathan Brown's Thought on the Hadith in the Context of the Aisha's Marriage Age Controversy)

The debate surrounding the hadith on the age of Aisha's marriage has long served as a source of criticism against the life of Prophet Muhammad (peace be upon him), particularly due to perceptions that the marriage constituted an unethical form of child marriage. This criticism has prompted scholars to re-evaluate the authenticity of the hadith's text, often without realizing that their judgments are deeply rooted in modern values. This study addresses the issue by formulating three key research questions: (1) How is the hadith concerning Aisha's age at marriage understood within the context of child marriage? (2) How do modern values inform the critique of the hadith's *matn*? and (3) How can Jonathan Brown's decolonial approach to *matn* criticism be applied to analyze this hadith?

To answer these questions, this research adopts the Critical Discourse Analysis (CDA) method developed by Michel Foucault and Norman Fairclough. This approach is employed to examine the construction of language and discourse in Jonathan Brown's works as well as in academic debates concerning the hadith on Aisha's age at marriage. The analysis is carried out in three main stages: description, interpretation, and explanation. CDA is chosen for its capacity to uncover the dynamics of power and discursive domination that shape religious interpretations under the influence of modernity.

The findings of this study reveal three major interpretive tendencies regarding the hadith: traditionalist, modernist, and contextualist, with the contextualist group attempting to restore the hadith's meaning to its historical context. The criticism of this hadith is often shaped by modern ethical frameworks, which frequently produce negative assessments. As an alternative, the "decolonization of *matn* criticism" approach derived from Jonathan Brown's thought offers a framework for liberating hadith interpretation from the hegemony of modernity, emphasizing the importance of historical context and the Islamic intellectual tradition. Therefore, this approach should be further developed in contemporary hadith studies to promote interpretations that are more just and contextual, and free from the hegemony of modernity or intellectual colonialism.

## الملخص

أثار الحديث المتعلق بسن زواج السيدة عائشة جدلاً واسعاً وانتقاداتٍ موجهة لحياة النبي محمد ﷺ، لا سيما وأن هذا الزواج غالباً ما يُنظر إليه على أنه ممارسة للزواج المبكر غير الأخلاقي. دفعت هذه الانتقادات بعض الباحثين إلى إعادة النظر في صحة متن الحديث، دون إدراك أن تقييماتكم غالباً ما تستند إلى قيم الحداثة. تنطلق هذه الدراسة من هذه الإشكالية، وتطرح ثلاثة تساؤلات رئيسية: (١) كيف يفهم الحديث عن سن زواج عائشة في سياق الزواج المبكر؟ (٢) كيف تؤثر قيم الحداثة في توجيه النقد إلى متن الحديث؟ و(٣) كيف يمكن توظيف منهج إزالة الاستعمار من نقد المتن في فكر جوناثان براون لتحليل هذا الحديث؟

وللإجابة عن هذه التساؤلات، تستخدم هذه الدراسة منهج تحليل الخطاب النقي (Critical Discourse Analysis) كما طوره ميشيل فوكو ونورمان فيركلاف ، لتحليل البناء اللغوي والخطاب في مؤلفات جوناثان براون وفي المجل الأكاديمي المتعلق بحديث سن زواج عائشة. تم تطبيق التحليل عبر ثلاثة مراحل رئيسية: الوصف، والتفسير، والشرح. وقد تم اختيار هذا المنهج لقدرته على كشف أبعاد السلطة وهيمنة الخطاب المدائي في التفسير الديني.

أظهرت نتائج الدراسة أن الفهم المتعلق بحديث سن زواج عائشة ينقسم إلى ثلاثة توجهات: تقليدي، حداثي، وسياسي، حيث يسعى الاتجاه السياسي إلى إعادة الحديث إلى سياقه التاريخي. إن النقد الموجه لهذا الحديث يتأثر كثيراً بقيم الحداثة، مما يؤدي غالباً إلى تقييمات سلبية. وكبدليل لذلك، يقدم منهج "إزالة الاستعمار من نقد المتن" المستمد من فكر جوناثان براون إطاراً لتحرير تفسير الحديث من هيمنة الحداثة، مع التأكيد على أهمية السياق التاريخي والتراث الفكري الإسلامي. عليه، فإن هذا المنهج بحاجة إلى مزيد من التطوير في الدراسات الحديثية المعاصرة من أجل تقديم قراءة أكثر عدلاً وسياسية، وخالية من الهيمنة الحداثية أو الاستعمار الفكري.
